Annually, the results of professional licensure exams are collected and reported to the Commission on Higher Education (CHE). The SCTCS Chief Academic Officers (CAO) Peer Group has reviewed and recommended licensure exams that should be reported for the 16 technical/community colleges. Exams that are not a program requirement and exams available only via self-reported data have been excluded from the exam list.

Reporting Licensure Exam Results

- The collection of results data for professional examinations should include first-time test takers for those students who completed an examination during the period of **April 1, 2021, through March 31, 2022**.
- Continuing education students should not be included in the results.
- Due August 15, 2022
