Medical Coding Certificate

The medical coder is a health information professional trained to assign diagnostic and procedural codes, applying classification systems for appropriate reimbursement in a variety of healthcare settings. The medical coder will establish a familiarity with other coding and classification systems utilized in nontraditional health care settings as well as reimbursement-related issues and skills including DRG assignment/validation, federal reimbursement systems and operations of third party payers and billing departments. Students completing the program are encouraged to sit for a national certification examinations administered by the American Health Information Management (AHIMA) and/or the American Academy of Professional Coders (AAPC).

- Certified Procedural Coder (CPC)

General Requirements (all required documents must be attached for consideration)

- Applicants must have submitted an **application for admission** to the College.
- Applicants must have completed the following prerequisites with a grade of "C" or better:
 - o All required transitional education courses
 - o ENG 101
 - o MAT 101
 - o AHS 102 Medical Terminology (within 5 years of application date)
 - o BIO 112 Basic Anatomy and Physiology (within 5 years of application date)
- Applicants must complete all program courses with a grade of "C" or better.
- Students must have a minimum 2.5 cumulative grade point average (GPA) (considering all academic course work, including prerequisites, within the last 10 years). Cumulative GPA will be calculated by ATC personnel upon receipt of application in accordance with the Health Sciences Division guidelines for GPA calculation.
- Once admitted, students will be required to complete and pass a criminal background check and drug screening scheduled by the Health Sciences Division. Depending on the result of the background check and drug screening, a student may not be able to participate in clinical and will be withdrawn from the program.
- Hands-on coding practice will be achieved in lab settings, and when possible, at clinical sites located throughout the
 communities of Aiken, North Augusta, and Augusta. Clinical sites are assigned and are determined by availability at
 medical facilities. Students are required to have reliable transportation for clinical rotations and be physically able to
 meet the clinical requirements.
- Applicants whose first language is not English must submit official TOEFL scores. A minimum score of 78 on the TOEFL iBT exam is required to be eligible to apply to the program. English as a Second Language (ESL) courses are strongly recommended.
