- 2. Legal Information
 - A. Title 17 of the United States Code is the statutory copyright law of the United States.
 - B. Section 106 of the statute describes the five basic rights of copyright owners. They are to reproduce, publish, prepare derivative works, to perform, and to display copyrighted works.
 - C. Major limitations to the rights of the copyright holders are set forth in Section 107 of the statute (Fair Use exemption) and Section 110 (Face to Face teaching and T.E.A.C.H. Act exemptions).
- 3. Copyright information and permission
 - A. The Library has information on copyright guidelines. Library staff cannot provide legal advice.
 - B. Each department chair/director is responsible for posting appropriate copyright notices on equipment for public use.
- 4. Penalties

Employees who violate copyright law may be subject to disciplinary action up to and including termination.
