APPROVAL OF MINUTES - September 11, 2023

Mr. Alvin Padgett motioned to approve the minutes. Ms. Keyatta Priester seconded the motion. The Commission unanimously approved the September 11, 2023, minutes.

A. Administrative Services - Mr. Andy Jordan

1. FY 23 Audit

Summary of Issue: The Commission received copies of the Financial Report and the Auditor's Discussion & Analysis Financial & Compliance Audit Summary for Fiscal Year 2023. Mr. Brian Nicholson from Mauldin & Jenkins CPAs highlighted items in the reports. The auditors gave the FY23 financial statements a clean, unmodified opinion with no deficiencies or weaknesses. In response to Ms. Jennifer Curtis's question about past audit results, Mr. Jordan and Dr. Mahan noted that the College has earned consecutive positive audit results in recent years.

Action Taken: Mr. Bill Windley motioned on behalf of the Building and Finance Committee to approve the FY 23 Audit. The motion passed unanimously.

2. Capital Projects Update

Summary of Issue: The College continues to work on several improvement projects throughout campus. Mr. Jordan reported on various work, including office and classroom painting, Welding and Grinding Lab updates, new carpeting and flooring in the Library, and the development of new directional and building entrance signs. The Welding and Grinding Lab work will be done over Christmas break, so classwork will not be interrupted. The College is processing the lease paperwork for the new Aiken County Career and Technology Center to be built on campus in partnership with the Aiken County Public School District. The Nursing Building Committee held its kick-off meeting with the architects, Compass 5 Partners, on September 27. Nursing building meetings will continue with the architect to develop the design and site selection.

E. Office of the President - Dr. Forest Mahan

1. College Update

Summary of Issue: Dr. Mahan reported no changes to the SC Technical System FY25 state budget request, which requests an additional \$20 million in recurring funds, \$51.1M for LTA, \$95M for SC WINS, and \$30M for Equipment for High-Demand Jobs Skills Training.

Dr. Mahan participated in a Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) site visit in Beeville, TX the first week of October.

The ATC Foundation is hosting its Scholarship Fundraiser on October 19.

Dr. Mahan will attend the Savannah River Site Community Reuse Organization (SRSCRO) retreat on October 29-31.

Dr. Mahan and Ms. Curtis attended the National Association of Community College Trustees annual Leadership Congress October 9-12 in Las Vegas. Dr. Mahan received the Chief Executive Officer of the Year award by the Southern Region from the Association of Community College Trustees at the annual awards banquet. Ms. Curtis was impressed by the conference and reported the importance of data use for student retention discussed at the conference. Other conference discussion focused on fewer people attending college at all, 2 or 4 years, and how colleges can address that.

Dr. Mahan, Ms. Priester, and Ms. Curtis will attend the ACCT Legislative Summit in February 2024 in Washington, D.C.

The College is working with the Aiken County Legislative Delegation to fill the two open Commission seats.

Dr. Mahan reminded the Commission of the Commission holiday dinner on November 13.
